TECHNICAL BACKGROUND

Barchester's IT infrastructure is managed out of their facilities in Inverness in the North of Scotland for the entire UK.

Each care home is equipped with five or six workstations and permanently backs up tens of gigabytes to a central server of several Tera Bytes.

- The connection between the care homes and the central site can be very variable. The solution must be able to work even with very low data rates.
- Health data is sensitive data. It is imperative to guarantee the confidentiality and integrity of the stored data.

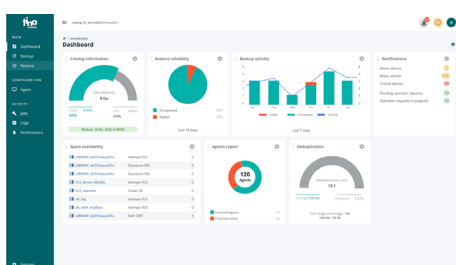
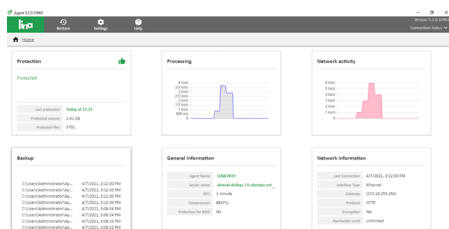
