#### **CHALLENGE**


Upon launching, General Assembly faced several critical challenges. The company opened its doors amid two significant Hollywood union strikes that halted production across the industry. Producers and studios sought costeffective post-production services, particularly for documentary filmmakers, so the need for reliable and budget-friendly solutions became urgent.

General Assembly struggled with managing increasing data volumes and the limitations of its existing infrastructure. They relied predominantly on Mac systems and handled a wide array of media across multiple storage systems, including Quantum SANs for finishing, NAS repositories, LTO tapes for archiving, and cloud solutions for backup. The existing solutions were increasingly inadequate, leading to inefficiencies, wasted time, and potential security risks. They required a tool to integrate seamlessly with various storage architectures and provide reliable and cost-effective data management while adhering to strict security and operational protocols.

SOLUTION

General Assembly needed to find a solution to automate their data management processes, adhere to strict protocols, and efficiently integrate with various storage systems. They chose Atempo Miria for several reasons:

#### **DEPLOYMENT**

The deployment of Atempo Miria involved close collaboration between General Assembly, Atempo's expert team, and their system integration partner, Alt Systems. Working together, they designed a comprehensive deployment strategy explicitly tailored to the unique needs of General Assembly. The process began with extensive discussions and assessments of existing workflows, technologies, and specific challenges. This careful planning was crucial in ensuring that the new system was compatible with their current operations and did not cause major disruption to their overall productivity.

Upon deploying Atempo Miria, General Assembly began using the software to archive their data from multiple sources, including Dell servers and LTO tape drives. Miria's capabilities allowed seamless data archiving to three LTO tape drives from a Dell server without complications.

Training sessions were also held for General Assembly's staff, providing them with the knowledge and skills necessary to leverage the new system effectively.

#### **ENHANCING FUTURE GROWTH**

In their ongoing efforts to optimize data management processes, General Assembly further enhanced their deployment of Miria by incorporating a sync license. This strategic improvement introduced a range of benefits that significantly boosted operational efficiency. Previously, their intermediary secure storage system presented challenges, as studios required all incoming media to be directed to this storage for thorough scanning and inspection before moving to production storage. With the recent update to Miria, which includes the move functionality offered by the sync license, their approach has been transformed. Currently, approximately 60% of all file movements in their facility are managed directly by Miria, and they anticipate increasing this to 80% as they explore and implement additional workflows that take advantage of these new features.

### **RESULTS**

Implementing Atempo Miria brought significant immediate benefits to the company. By automating archiving processes, operational efficiency saw marked improvement, allowing the company to enhance customer service and realize cost savings. Miria's compatibility with various storage architectures simplified data management, leading to more reliable and cost-effective operations.
